2007-2008 Alternative Loans Non- FAFSA Applicants Only

Every student that completes the Free Application for Federal Student Aid (FAFSA) and meets minimum eligibility criteria (citizenship, Selective Service registration, no defaulted loans, etc.) will at least be eligible for the Federal Stafford Subsidized loan and/or Federal Stafford Unsubsidized loan.

The Federal Stafford Subsidized loan has a fixed interest rate. You have a 6 month grace period after you graduate or drop below ½ time before repayment is required. This loan does NOT accrue interest while you are in school. The Federal Stafford Unsubsidized loan has a fixed interest rate. You have a 6 month grace period after you graduate or drop below ½ time before repayment is required. This loan DOES accrue interest while you are in school.

If you have filed the FAFSA, or plan to file one for the 2007-2008 academic year, (our priority deadline in Feb. 14th) along with the KUMC Student Data Form, Student Financial Aid will review the processed FAFSA application for eligibility in all financial aid programs. Our office will award the financial aid package and notify you via email for your acceptance/decline of the award aid. At that time, eligibility for alternative loans will be based on your cost of attendance minus any other aid you accept or are awarded, including scholarships, grants, and federal education loans.

Please read to following and check **only** the statement that is true for 2007-2008. If you have questions about which statement should be checked, contact the student financial aid office.

- I have completed the FAFSA and Student Data Form and selected KUMC as my institution of choice for financial aid. I understand my alternative loan application will be processed after the FAFSA application is processed.
- I have not completed the 2007-2008 FAFSA, but will complete the FAFSA and Student Data Form to be considered for financial aid at KUMC. I understand my alternative loan application will be processed after the KUMC Financial Aid process is complete.
