#### Overview

The MSHA portion of the dual MSHA/MD degree offered through the Department of Population Health is available to those who already have a medical degree and meet the eligibility requirements.

The MSHA curriculum combines social science and business content in the context of health care and prepares students for management and leadership positions in health care organizations. As the health care environment becomes more complex and competitive, administrative skills will be extremely important to individuals starting careers in medicine or those seeking to enhance their current careers.

#### **Eligible applicants must:**

-have a **medical degree** (MD, DO, or MBBS);  
-**be in an ACGME-accredited residency, a residency or fellowship sponsored by an ACGME-accredited institution, or hold an active and unrestricted medical license in Kansas or Missouri**

#### **MD/MHSA Admission Requirements**

**Pre-requisite:** Undergraduate course in statistics prior to beginning coursework in the Program.

#### **Application Requirements:**

1. A completed **application** for admission.
2. A non-refundable **application fee** (\$60 for domestic and international applicants).
3. **Official transcripts** of all previous academic work beyond the secondary level. To be admitted as a regular graduate student, applicants must have not less than a B average GPA (3.0 on a 4.0 scale) overall.
4. Names and emails of **three references**.
5. A **personal statement**, (two pages maximum) outlining reasons for wanting to pursue a graduate education in health services administration as well as career objectives.
6. A **current CV or resume**.
7. A **letter from the Residency Program Director** verifying good standing in your residency (if currently in a residency).
8. A **copy of your unrestricted medical license (if GME has already been completed)**.
9. Each competitive applicant will be invited for an **admissions interview**.

The Department of Population Health reserves the right to limit the number of students admitted to the MD/MHSA program per year.
