

At the end of FY2022, I completed my forty-seventh year at the University of Kansas Medical Center. During my more than four decades at KUMC, I have never hidden my love of New York City, where I grew up, and its bridges that link the five boroughs.

There is a powerful analogy with the bridges we build in Kansas as an academic health science center with its missions of research, service, and education. Many bridges are inanimate objects. Our bridges are human connections between the departments and teams that comprise our Division of Academic and Student Affairs (OASA) and our learners, staff, and faculty constituencies.



On the academic affairs side of OASA, we help Graduate Students and Postdoctoral Fellows bridge the gap to their future careers through programming that spans the spectrum of career opportunities from academia to industry. We maintain and enhance the faculty life cycle by facilitating career development including hiring, promotion, sabbaticals, and yes, retirement, with guidance through phased retirement and emeriti status. We enhance communication to faculty in the three schools by staffing the Faculty Assembly Steering Committee, the overarching medical center faculty governance body. It is the interface between KUMC leadership and the faculty we serve.

Every morning when I arrive at work, I read the quote from Shelby Foote along the stairs of the Dykes Library: "A university is just a group of buildings gathered around a library." The remainder of the quote is the "library is the university" and the Dykes library is at the core of our academic health science center. Our team of librarians promotes education and learning, inspires research and discovery, and provides key connections to the KUMC community and beyond. The library joined OASA in July 2021 and we have seen the library team continue their expertise as information professionals building and growing partnerships and collaborations within OASA and throughout KUMC.

Academic Accommodation Services

In the Office of Academic Accommodation Services, we know the path to success is not always easy, and students may need help on their journey. We facilitate and provide equal educational access and opportunity for all members of our community. Our mission statement includes provisions for individual accommodations and plays a significant role in fostering an inclusive, welcoming campus community.

Our office continues to implement campus changes by empowering students and providing educational programming to various constituencies on policy and regulation updates. We further the interactive process of engaging the student, the associate dean, department chair, program director and other appropriate participants to evaluate all accommodation requests. The goal is to demonstrate good faith efforts in addressing the needs of the student for success while ensuring that program standards are maintained.

During the pandemic, there was a surge in need for accommodations, ranging from remote classes to the use of masks when classes resumed. As our educational programs resume in a "new normal" educational environment where students are back on campus, students with disabilities may need to continue some adjustments engendered by the last 3 years. Hopefully, the pandemic experience we have all endured has opened our eyes to accommodation needs and made us more accepting and aware of ideas and approaches that might improve the educational environment for persons with disabilities. Our office will continue to support our student's success in this ever-changing environment.



A. R. Dykes Library



The A.R. Dykes Library of the Health Sciences transferred from Enterprise Support Services/Information Resources to the Office of Academic and Student affairs on July 1, 2021. The library supports students, faculty and staff from all schools, institutions, and centers on all KUMC campuses to help them advance their educational, research and clinical goals.

The Dykes library has a local, regional, and national presence with other medical center libraries and with colleagues on the Lawrence, Wichita, and Salina campuses. Librarians participate in health care dissemination and community outreach initiatives through campus partnerships and with the Network of the National Libraries of Medicine. The library building is staffed to provide reference assistance to users via face to face, phone, email, and live chat. Interlibrary loan services provide journal articles and books from the library's collection and from other libraries on behalf of KUMC faculty, staff, and students.

Biomedical librarians are expanding partnerships with faculty, staff and students in scholarly communications and data management education support through instruction about and participating in systematic reviews and other more advanced instruction and consultation sessions, integrating information literacy instruction into course curriculum, and using data analysis tools to help make informed decisions about resource usage and costs.










Increases over the past 5 years

Highlights

Collaborated with Kansas City Graduate Medical Education to increase wellness among female residents, and to increase recruitment of residents who identify with an underrepresented minority cohort Collaborated with Graduate Medical Education to provide pre-scheduled second year Resident Wellness visits to thirteen residency programs.







CIPER PROGRAM ASSESSMENT PROCESS




Kirmayer Fitness Center



Graduate Studies


The Office of Graduate Studies provides guidance and support for master's, Ph.D., clinical doctorate, and graduate certificate programs offered at KUMC.

Enrollment by Degree Type




Graduate Teaching, Research, and Assistants (GTA/GRA/GA)

In FY22, the Office of Graduate Studies collaborated with academic units across campus to support 285 students in Graduate Teaching Assistant (GTA), Graduate Research Assistant (GRA), and Graduate Assistant (GA) roles. We bridged the divide between campuses to hire several Lawrence students whose academic pursuits synchronize with research being conducted at the medical center.



Considerable effort was made to fairly compensate these student employees, and we are proud that the minimum salary for doctoral students has increased 16.6% from FY21, making KUMC competitive for outstanding students.



Student Research Forum

The 2021-2022 Student Research Forum celebrated another triumphant year showcasing research from the Schools of Health Professions, Medicine, and Nursing. The student-led Planning Committee, with the support and guidance from the Office of Postdoctoral Affairs and Graduate Studies, successfully returned the forum to campus, and featured a presentation by Dr. Ada Yonath, a Nobel Laureate from Israel.




The Registrar's Office proudly provides support and services to our active military and veteran students.






Student Financial Aid

The Student Financial Aid Office (SFAO) is committed to helping students obtain necessary funding to pay for their education through institutional, state, federal and private sources.

The Student Financial Aid Office is dedicated to enhancing the financial literacy of students. This year, in addition to providing funding to help students cover the costs of their education, a focus was placed on increasing awareness and understanding of personal finance.



School of Medicine Enrichment and Remediation (SER)

The Student Financial Aid Office partnered with Dr. Erin Bider, to offer three different week-long sessions as SER experiences for 1st and 2nd year medical students.

With the help of students, courses were designed with experts on the topics of budgeting, investing, taxes, retirement accounts, legal issues, insurance, student loans, credit scores, and the advantages of home buying vs. renting.

Higher Education Emergency Relief Fund

This past year, the federal government provided a third round of Higher Education Emergency Relief Funds (HEERF III). SFAO worked with KUMC leadership to identify students with exceptional need who would benefit most for this emergency funding.

1,175 recipients

While some students were selected based on the information provided through the standard financial aid process, others were able to submit applications detailing specific needs due to COVID,

This year, we had the new ability to provide support to students studying completely on-line as well as assisting students who had been omitted from earlier HEERF programs.

Funding was awarded to assist with unexpected costs for housing, food, course materials, technology, transportation, health care, and childcare.

Maintenance of Effort Scholarship

As part of the federal funding programs, state governors were provided with money to assist universities with pandemic related expenses, some of which was designated for need-based scholarships for students. This additional funding was used to assist students who demonstrated a high level of unmet need, but who were not eligible for Federal Pell Grants and were often excluded from institutional scholarships, being slightly above the need thresholds established for the awards.

Student Health Services

The mission of Student Health Services (SHS) is to provide evidence- based care for students and support the academic mission of the university. We provide holistic health care that supports the personal and professional success of our students.

This past fiscal year, we ensured students had access to well-fitting N95 masks, vaccinations, and health requirements for seamless transition to clinical practice and research endeavors. We coordinated with the University of Kansas Health System to provide testing and care for individuals with COVID-19 infections. For those students who needed assistance, we worked with schools to offer access to virtual academic options when possible.

N95 Masks

Ng5 masks have become an essential piece of protective equipment for our clinical students. To meet the increased demand and ensure student safety, we coordinated with an outside vendor and Environmental Health Services. Additionally, we performed the medical evaluation and fit testing on 308 students at SHS. Students could access masks at the clinical site, but if that was not possible, masks were given to the student or department to ensure access.



710 students and clinical researchers were fit for an N95 mask

More than 83% of KUMC students use our services for primary or nursing care.

Of those students, 93% would recommend the services to a fellow student.




